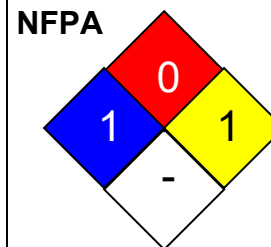
## SECTION 4 -- FIRST-AID MEASURES

**Eye Contact:** IF IN EYES: Hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Get medical attention.
